

# Ready Defense: An Introduction to Christian Apologetics (D3)

**I. Course Description:** This course is intended as an introduction to the definition, purposes, and methodologies of effective Christian apologetics. We will examine several standard lines of reasoning that affirm the truth of Christianity. We will also consider well-reasoned responses to some of the more common arguments and objections laid against Christianity. From Gregory Koukl's book, Tactics, we will introduce a practical methodology for crafting conversational conditions that promote active thinking about the reasonableness of belief in Christianity while gently pointing out serious flaws in other systems of thought. Importantly, as ambassadors for Christ, we will maintain a focus on the appropriate attitude, tone, and demeanor of one making a defense for the faith of Jesus Christ with gentleness and respect.

## **II. Course Objectives:**

- -Equip students with proper attitudes for engaging in apologetic conversations.
- -Equip students with general knowledge of practical methodologies and skills for defending the faith of Jesus Christ in a civil and courteous manner.
- -Equip students with general knowledge of how to address common arguments and objections to Christianity.
- -Encourage students to have greater confidence & competence for defending the faith of Jesus Christ.
- -Inspire students to have a deeper affection for Christ in view of the reasonableness of the Christian faith.
- -Inspire students to have a deeper love for others that manifests in gracious and respectful dialogue with others about issues of great importance.
