#### I. OC Mission Statement:

Oklahoma Christian University is a higher learning community that transforms lives for Christian faith, scholarship, and service.

#### II. Course Description

This course will introduce students to the Christian worldview. Basic life questions will be explored in light of the biblical story as a whole. Students will learn the basic content of the Bible and methods for responsibly interpreting the Old and New Testaments within a Christian framework. The course will also explore basic Christian beliefs—the Godhead, creation, sin, redemption through Jesus, and the church. This course will compare the biblical worldview with other worldviews, most notably secular humanism.

#### III. Christian Worldview & Teaching Philosophy

This course is an Oklahoma Christian University Bible course offered for credit through the Northwest School of Discipleship (NWSD), Tigard, Oregon. NWSD is a church-based educational initiative that seeks to help transform believers into the image of Christ through offering biblical courses grounded in the three essential features of discipleship: Knowledge, Affection, Obedience.

#### IV. Course Goals:

- 1. **Understand** the Bible as a unified whole and a coherent story.
- 2. Interpret Scripture historically, literally, and theologically.
- 3. Articulate basic Christian beliefs about God, humans, and the world.
- 4. Analyze other cultural worldviews in terms of the Christian worldview.
- 5. **Explain** how one's personal mission and calling fits within God's mission.

#### V. Course Textbooks (Required)

- Natasha Crain, *Faithfully Different*. Harvest House Publishers, 2022. (ISBN 978-0-7369-8429-4)
- The Holy Bible, ESV. Crossway Publishers, 2001. (Another reputable translation may also be used by the student, but memory work will be tested from the ESV.)

#### VI. Course Requirements

- Participation and Attendance Participation is based on completion of assigned exercises, evidence of preparation for class, and a general assessment of classroom presence, involvement, effort, improvement, and achievement. There are no excused absences, but all students are allowed one unexcused absence. Each absence after the first will result in lowering the participation grade by 10%. Four or more absences may result in failure of the course.
- Memory Work A list of Scriptures will be memorized as a part of this course, in addition to memorizing some helpful lists. The memory work will be tested on the daily quizzes, the mid-term exam, and the final exam. The details are found in the "Memory Work" handout.
- 3. **Daily Quizzes** -- Most class days will begin with a quiz over that week's required readings from our textbook, *Faithfully Different*, that day's memory work, and the assigned readings of Scripture. Daily Quizzes will not be given on exam days. There will be no "make up" quizzes. Instead, the professor will drop the lowest quiz score (including a zero) when averaging quiz grades.

As you read the assigned Scripture readings, consider these questions:

- What KIND of text is this? (a letter, poem, story, law, etc.)
- What is happening in the text? What is the plot, who are the main characters, and what is the setting?
- In your opinion, what does this text tell us about God? About humanity? About the world? What does this text contribute to a biblical worldview?
- 4. Reflective Essays -- Three reflective essays are required in this course. Reflective essays are NOT research papers where you report what others have written, but rather are your own thoughtful personal reflections upon a given subject or text. You will draw from your own knowledge and experience, so no footnotes are required. Biblical quotations are encouraged when appropriate, with the reference given after the Scripture: (John 3:16, ESV). Essays will be at least 700 words each. Proper English grammar, spelling, and conventions are to be utilized. You may use the first person ("I") since you are writing your own reflections. Refer to the handout on Reflective Essays for further instructions, including the topics covered. The three essays will be 20% of your total class grade. All

three essays must be completed to pass the course. Assignments are due at the beginning of a class period; late work will be penalized one letter grade per calendar day late, beginning with the day due.

5. **Exams** -- A mid-term exam and a final exam will be given. The final exam will be comprehensive. Students should plan to take the midterm and final exams on the day they are scheduled. Any exceptions require the approval of the professor *before* the exams are given on the dates scheduled.

### Oklahoma Christian University Policy on Academic Honesty

#### Cheating

Cheating is one form of academic dishonesty. Cheating triggers the Consequences for Academic Dishonesty.

#### Plagiarism

One particular form of cheating is plagiarism. Plagiarism is the transmission of another's ideas, words, or materials as one's own and/or the failure to accurately credit the ideas, words, or materials of another. Plagiarism also includes passing off another person's work as one's own. Plagiarism undermines the ethics of the academy and the specific Christian purposes of

Oklahoma Christian University. Plagiarism is one form of academic dishonesty. Plagiarism triggers the following consequences.

#### Consequences for Academic Dishonesty

- First offense: the mandatory consequence for academic dishonesty with regard to an examination or assignment is zero (0) credit. Faculty have discretion to assign appropriate consequences for academic dishonesty other than on examinations or assignments. Faculty must send documentation of the first offense to the appropriate chair, the dean of the appropriate college, the CAO, and the Dean of Students.
- Second offense: the mandatory consequence for a second incident of academic dishonesty, in the same course, during the same term, is a failing grade (F) in the course. Faculty shall provide documentation of the second offense to the appropriate academic leader, dean, CAO, and the Dean of Students.
- 3. Appeal: A student accused of academic dishonesty may appeal the determination using the process for Grade Appeals, found below.
- 4. Multiple Course Violations: When a student has been academically dishonest in more than one (1) course the Academic Appeals Committee may assign consequences up to and including suspension from the University. The Academic Appeals Committee will inform the CAO and the Dean of Students in writing of consequences imposed and will report annually on its activities to the University's Academic Affairs Committee. 5. Faculty should maintain the highest standards of academic honesty both in and out of the classroom. Faculty must report and apply the rules regarding academic dishonesty to the appropriate channels.


